



Intro EPEP project

On May 19, 2010, the EU Directive EPBD, 2002/91/EC has been updated, specifically for buildings with a cooling capacity of >12 kW. This EPBD contains guidelines, methods and requirements for regular, periodic inspection, testing and certification of the energy performance of old and new buildings. Due to this regulation there's now an urgent need on the labor market for well qualified individuals to inspect, certify and maintain installations for the comfort persons (>12 kW). In the of partnership a growing shortage exists of certified inspectors to fulfill the requirements of the EPBD. Also there's a lack of up-to-date training courses, competence profiles and exams in these fields. The EPEP project contributes to this matter!

Main Aim of the EPEP project

The main aim of the EPEP project is to optimize the competence profiles, update training materials/ approaches for the sectors electro, installation & maintenance to be able to fulfil the obligations of the EPBD. Main objective: transferring innovation in knowledge between VET- and VET-related organizations on inspection & certification of installations for the comfort of persons, >12 kW.

EPEP Project Results

There is a urgent need for the proposed project results such as:

- Competence profiles, materials, methods and approaches fit to the EU Directive EPBD,2002/91/EG
- ICT D-base with competence profiles, teaching-, training- & lesson materials
- ICT measurement / assessment tool for the screening / assessment, validation of prior learning, personal development & lifelong learning of competences
- > Pilots / tests for trainers, teachers, students / workers
- Information for sectors (EU), f.e. through seminars, periodical publications
